**Open Letter**

27<sup>th</sup> December 2011

Dear Ms. Lagarde,

From the *Global Isles Court of Record* of our Sovereign Lady of the Common Law, Greeting!

*This court* would like to bring to the kind attention of the International Monetary Fund (IMF) the enclosed class action lawsuit that will assist the Managing Director in the delivery of the highest ethical standard to the IMF as you have contractually agreed, that is, the due process of the Common Law.
