The multi-state corporate institutions, the UNITED STATES, EUROPEAN UNION, UNITED NATIONS and AFRICAN UNION and any others like these, are hereby dissolved by the grace of YHVH as Elohim, the judge.

It is my wish as plaintiff and as Lord Keir Argent, by the grace of YHVH, Duke of Switzerland in Your Majesty's Commonwealth who has been wronged by banks in multiple jurisdictions, that all correspondent accounts in New York City are closed.

Restoration of real property

It is my wish before YHVH as Elohim that all these corporations are dissolved. One living man or woman must come forward to receive real control of the chattel that these represent.
