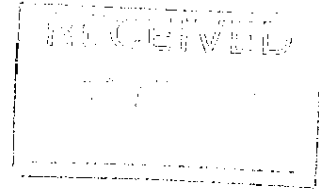

Review of our banking relationship

We periodically conduct strategic reviews of our services, products and accounts. Unfortunately, this means that we have taken the decision to close some customer accounts where they do not meet our strategic criteria. I am not able to provide further details about the internal processes HSBC uses when reviewing accounts. The decision to close your account was taken based on a careful and thorough review of your account and HSBC will not be revisiting this decision.
